The United States Tax Court will hold a Judicial Conference beginning in the evening on Monday, March 26, 2018, and concluding mid-day on Wednesday, March 28, 2018. The Court's Judicial Conference provides the attendees with the opportunity to (1) review and discuss issues of material interest regarding the tax litigation process, (2) discuss ways in which the tax litigation process in the Court may be improved, and (3) network with fellow Tax Court practitioners. A variety of plenary and breakout sessions, which will be held at Northwestern University's Pritzker School of Law, will address issues relevant to practice before the Court. The cost of the conference is estimated to be \$450.00.

In the interest of expanding the discussion and providing as diverse a conference community as possible, the Court would like to encourage academics, clinicians, members of the Tax Court Bar, and other interested parties to apply to attend and participate in the 2018 Judicial Conference.
